- You will not be able to rejoin the Parliamentary Superannuation Scheme PSS 3 at a later time.
- The Government contribution paid into the selected fund will only be equal to your entitlement under the Superannuation Guarantee.
- You will need to provide evidence that the selected fund is complying and will accept contributions from the Government.
- You cannot select a Self Managed Superannuation Fund as the fund to accept these contributions.
- You will not be entitled to any insurance cover under the Parliamentary Superannuation Scheme PSS 3.
