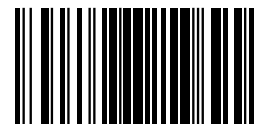

! Contributions to Triple S will not count towards the First Home Super Saver Scheme (FHSSS). All contributions to an untaxed fund are specifically excluded under the Commonwealth rules.

There is no limit on the maximum percentage of after-tax contributions that you can make. However, the percentage needs to be a whole percentage.

Important Please note that your after-tax contributions are based on a percentage of your salary before tax.
